

AUTHOR'S GUIDELINES

ENGLISH VERSION

PsiLogos Journal, published twice a year by the Department of Psychiatry of Prof. Doutor Fernando Fonseca Hospital (Amadora, Portugal) publishes editorials, original articles, review articles, clinical case reports, book reviews or other works of interest to the field of Mental Health. Articles are published according to CC-BY-3.0 Creative Commons Licence (open-access standards) at no cost to the author nor the reader.

The proposed manuscripts, written in Portuguese or English, may not have been previously published (nor being in the process of evaluation) at any other journal and should be sent to the care of the Director of the Journal. The submission is made in digital format (Microsoft Word ® or compatible documents) by emailing the manuscript to mafalda.m.miranda @ gmail.com. If there are any images, they should be sent as separate files (PDF, TIFF or PNG formats only). Submissions must be accompanied by a declaration of conformity with the publication policy (available in PDF at the Journal's website). If informed consent is required, as defined by the journal's publication policy, it must be mentioned in the manuscript. Upon receipt, the work will be evaluated by the editorial board, which will consider whether it fits the scope of journal. If accepted, the work will be anonymized and sent for evaluation by external reviewers. The review process is double-blind and the editors-in-chief rely on a third party to process communication with reviewers (the reviewers/scientific advisors identification is available at the editorial board section of the PsiLogos website). After review, there are several possible outcomes as the article can: a) be refused b) be published after corrections proposed by reviewers, c) be published without changes. The reason for the refusal and comments of the reviewers or editorial committee will be made available to the authors.

The publication norms and style of references follow the recommendations of the International Committee of Medical Journal Editors (www.icmje.org), to which the authors must refer for cases not covered in this text. Authors are strongly suggested



to make use of the manuscript template (available at the PsiLogos website) and refer to previously published articles in order to produce manuscripts that comply to the journal's guidelines. Regarding the presentation of the text, articles should be written in double-space, with numbered pages in Times New Roman font, size 12. The numbering of figures is to be made with Arabic numerals and tables with Roman numerals. The text should not exceed 12 pages (lengthier articles might be accepted by the editorial board). The first page should include the title of the article in Portuguese and English, the name of authors, their qualifications and institutional affiliations (if any) and email the corresponding author (which will be placed in the published version). On the second page authors should include the abstract in Portuguese and English (maximum 350 words for original articles and reviews and 150 clinical cases), as well as the keywords in Portuguese and English, which must use MeSH (Medical Subject Headings) of National Library of Medicine (NLM). The summary should be structured as follows: introduction, objectives, methods, results and conclusions. The research papers should be structured according to the following: introduction, objectives, material and methods, results, discussion and conclusion, followed by a list of references, disclosure of interests and funding. The acknowledgments should be placed before the references list.

References should be numbered according to the order of appearance and inserted with "superscript" effect. In the reference list must only include those cited in the text and should be arranged in the same order. Refer to manuscript template for further reference guidelines.

A declaration of conformity with the publication policy (available in PDF at the journal's website) should be signed by the main author and sent along with the manuscript to be submitted.
